## **APPLICABILITY**

Applicable to commercial, small industrial, public, and three-phase farm members located in areas served by DSO who do not qualify for service under other DSO rate schedules.

#### **CHARACTER OF SERVICE**

Single-phase and three-phase where available, AC, 60 cycles, at available voltages.

### **RATE**

Availability Charge \$55.00 per month Energy Charge (June-September) \$0.119 per kWh Energy Charge (all other months) \$.099 per kWh Demand Charge \$1.25 per kW

Power Cost Adjustment TBD

If required transformer capacity is greater than 25 kVA, then Availability Charge shall be an additional \$20.00 per month.

# **POWER COST ADJUSTMENT (PCA)**

See PCA rate schedule.

### **DEMAND CHARGE**

The billing demand shall be the member's highest hourly demand during that month/billing period.

When indicated demand results are in a fraction, then nearest unit kW shall be used. Fractions of 0.5 or less shall be dropped and fractions of 0.6 or more shall be considered 1 kW.

#### **CONDITIONS OF SERVICE**

- 1. The rated capacity of single-phase motors shall not be more than 10 horsepower, unless approved by DSO.
- 2. A member with a home on the same premises as their business may include service to both home and business on the same meter and all service shall be billed under this rate schedule. Alternatively, the member may prefer to have service metered and billed separately for their home and business.

### POWER FACTOR ADJUSTMENT

If the member's power factor is found by test or by power factor metering to be less than 95% lagging, then the account shall be transferred to the General Service - Demand rate schedule.

#### MINIMUM MONTHLY BILL

The minimum monthly bill shall be the highest of the following:

- Availability Charge or
- a charge of \$1.25 per kVA of installed transformer nameplate capacity if the service is three-phase.

## **SEASONAL SERVICE**

Members requiring this service for seasonal usage shall be required to pay a monthly minimum each of the 12 months, as determined in accordance with the foregoing section.

# **TEMPORARY SERVICE**

Temporary service shall be supplied in accordance with the foregoing rate. The member shall pay the total cost of connecting and disconnecting service, less the value of materials returned to stock. DSO may require a deposit, in advance, of the full amount of the estimated bill for service, including the cost of connection and disconnection.

# **PAYMENT**

Payment terms are specified in accordance with DSO's Rules and Regulations.
