APPLICABILITY

Applicable to members of DSO for general, farm, and residential service.

CHARACTER OF SERVICE

Single-phase, at available voltages.

RATE

Availability Charge	\$44.50 per month
Energy Charge	\$0.074 per kWh
Demand Charge	\$1.00 per kW
Interruptible Credit	\$10.00 per Peak Alert
Power Cost Adjustment	TBD

If required transformer capacity is greater than 25 kVA, then Availability Charge shall be an additional \$20.00 per month.

POWER COST ADJUSTMENT (PCA)

See Schedule PCA.

DEMAND CHARGE

The billing demand shall be the member’s highest hourly demand during that month/billing period.

When indicated demand results are in a fraction, then nearest unit kW shall be used. Fractions of 0.5 or less shall be dropped and fractions of 0.6 or more shall be considered 1 kW.

DEFINITIONS

Control Peak Period is 3:00 p.m. to 6:00 p.m. (central time), Monday through Friday, during the months of July and August (excluding July 4).

Peak Alert is a day when a system-wide peak demand may occur.

TERMS OF SERVICE

- DSO shall turn off power to the member’s meter during the Control Peak Period on Peak Alert days.
- DSO may turn off power on multiple days.
- DSO shall notify members on this rate of a Peak Alert as soon as practicable, but at least 30 minutes prior to power being turned off.
- Peak Alert notifications shall be communicated via the member’s preferred method (email or text), as selected by the member in DSO’s SmartHub portal. Members on this rate are required to have an active SmartHub login.
- DSO may cancel a Peak Alert and shall notify the member of any Peak Alert cancellation.
- To receive the Interruptible Credit, the member’s power must be off during the Control Peak Period on a Peak Alert day.

- To receive the Interruptible Credit, the member must average at least 1.5 kW of load on their meter the hour immediately preceding the power turn off and the hour immediately following the power turn off. This 1.5 kW minimum average shall be determined by summing the loads for those two hours and dividing them by two.
- Interruptible Credits earned shall be credited to the member's bill.

CONDITIONS OF SERVICE

Service under this rate is limited to 10,000 kWh per month.

MONTHLY MINIMUM BILL

Same as Availability Charge.

PAYMENT

Payment terms are specified in accordance with DSO's Rules and Regulations.
